

## AT&T Invests More Than \$3-Billion Over 3-Year Period to Enhance Local Networks in Illinois

CHICAGO. July 19, 2015— At AT&T<sup>1</sup>, we invested more than \$3-billion in our Illinois wireless and wired networks during 2013 - 2015.

These investments drive a wide range of upgrades to reliability, coverage, speed and overall performance for residents and businesses. They also enhance critical services that support public safety and first responders.

"We're committed to providing our customers fast, reliable, highly secure connectivity throughout the state. We want them to be able access the Internet at any moment, from almost any device and anywhere," said Paul La Schiazza, president, AT&T Illinois. "Our continued investment in Chicago, the suburbs and downstate brings a host of new, innovative opportunities for Illinois residents and businesses."

"In order for Illinois to continue to thrive and serve its residents, it's important that we have companies willing to invest in our state to bring innovation and opportunity," said Congressman John Shimkus. "Private investment in communications networks helps provide residents and businesses the tools to compete and grow."

"Modern communications networks are essential for how we live today. They help our citizens learn, find a job, connect with family and friends and contact public safety officials and other emergency responders," said Congressman Adam Kinzinger. "The continued private investment coming into Illinois will improve our citizens' lives and our businesses' ability to compete. This is great news."

Notable Illinois network enhancements in 2015 included:

- AT&T enhanced wireless high-speed internet in Chicago buildings including: CTA,
  O'Hare Airport, Midway Airport and Union Station.
- LTE expansions to improve data speeds were made in the following counties:
  - LaSalle, Lee, Ogle, DeKalb, Iroquois, Cook, Will, DuPage, Coles, Montgomery, Macoupin, Tazewell, Christian, Effingham and Sangamon.
- LTE capacity was added to hundreds of sites to increase access to those improved data speeds (like adding lanes to a highway).
- AT&T U-verse with GigaPower was launched in Chicago and several other Illinois communities

We plan to continue to roll out our fastest Internet services over a 100% fiber network to reach more than 14 million additional residential and commercial locations.

We have big plans for 2016. We'll be giving you the ability to access and stream DIRECTV video services over a wired or wireless Internet connection from any provider and from virtually any device – smartphone, tablet, Smart TV, streaming media hardware or PC. We plan for each service to come with a set number of simultaneous sessions. These services will not require annual contracts, satellite dishes or set-top boxes.

We have an extensive Wi-Fi network with more than 40,000 AT&T Wi-Fi Hot Spots at popular restaurants, hotels, bookstores and retailers. We provide access to Wi-Fi at more than 1 million Hot Spots around the world. Most AT&T smartphone and home Internet customers get access to our entire national Wi-Fi network at no additional cost. Wi-Fi usage doesn't count towards customers' monthly wireless data plans.<sup>5</sup>
