

## AT&T Invests Nearly \$2 Billion Over 3-Year Period to Enhance Local Networks in Indiana

INDIANAPOLIS, July 7, 2016 — At AT&T<sup>1</sup>, we've invested nearly \$2 billion in our Indiana wireless and wired networks during 2013 -2015. These investments drive a wide range of upgrades to reliability, coverage, speed and overall performance for residents and businesses. They also enhance critical services that support public safety and first responders.

In 2015, AT&T made more than 375 wireless network upgrades in Indiana. This included new cell sites, addition of network capacity, and new wireless high-speed Internet connections.

"We're committed to providing our customers fast, reliable, highly secure connectivity. We want them to be able to access the Internet at any moment, from almost any device and anywhere," said Bill Soards, president of AT&T Indiana. "Our continued investment in Indiana brings a host of new, innovative opportunities for residents and businesses."

"In order for Indiana to continue to thrive and serve its residents, it's imperative we have companies that invest through thoughtful innovation," said State Sen. Brandt Hershman. "AT&T is making on-going investments in its fast, reliable network. With this, our residents and businesses have the tools to compete and grow."

Notable Indiana network enhancements in 2015 included:

- More than 20 new cell sites
- Fast 4G LTE speeds added to more than 45 cell sites
- Additional 4G LTE capacity added to more than 300 cell sites
- Launch of AT&T GigaPower in parts of Crown Point, Gary and Hammond

In 2016, for the second year in a row, FORTUNE magazine recognized AT&T as the Most Admired Telecommunications Company in the world. We also placed #48 among the Top 50 World's Most Admired companies. This is our third year in a row on the Top 50 list – AT&T is the only communications company on the list. We also offer our award-winning DIRECTV® service to eligible locations. Customers may be eligible for AT&T U-verse TV service, a 100% digital

AT&T GigaPower offers our fastest Internet speeds, up to 1Gbps<sup>4</sup> over a 100% fiber network to more than 1.6 million locations across 25 major metro areas. We've announced plans to expand the availability of Internet speeds up to 1Gbps to homes, apartments and small businesses in parts of 31 additional cities across the U.S. – which will total at least 56 metros served.

We plan to continue to roll out our fastest Internet services over a 100% fiber network to reach more than 14 million additional residential and commercial locations.

We have big plans for 2016. We'll be giving you the ability to access and stream DIRECTV video services over a wired or wireless Internet connection from any provider and from virtually any device – smartphone, tablet, Smart TV, streaming media hardware or PC. We plan for each service to come with a set number of simultaneous sessions. These services will not require annual contracts, satellite dishes or set-top boxes.

We have an extensive Wi-Fi network with more than 40,000 AT&T Wi-Fi Hot Spots at popular restaurants, hotels, bookstores and retailers. We provide access to Wi-Fi at more than 1 million Hot Spots around the world. Most AT&T smartphone and home Internet customers get access to our entire national Wi-Fi network at no additional cost. Wi-Fi usage doesn't count towards customers' monthly wireless data plans.<sup>5</sup>
