

AT&T Invests Nearly \$2.1 Billion Over 3-Year Period to Enhance Local Networks in the Greater Los Angeles Area

LOS ANGELES, Calif, May 23, 2016 — At AT&T¹, we've invested nearly \$2.1 billion in our Greater Los Angeles area wireless and wired networks during 2013 -2015. These investments drive upgrades to enhance reliability, coverage, speed and overall performance for residents and businesses. They also enhance critical services that support public safety and first responders.

In 2015, AT&T made 16 wireless network upgrades in the Los Angeles area. We added new cell sites and addition of network capacity.

Additionally, we expanded the reach of our network. In 2015, we added high speed Internet, TV and voice services to new customer locations in the Greater Los Angeles area. Some of these locations may also be eligible for AT&T GigaPowerSM, our ultrafast network delivering Internet speeds up to 1 gigabit per second (Gbps) over fiber.

"We're committed to providing our customers fast, reliable, highly secure connectivity. We want them to be able to access the Internet at any moment, from almost any device and from anywhere," said Jace Barbin, Vice President and General Manager of Mobility, Greater Los Angeles area, AT&T. "Our continued investment in the Greater LA area brings a host of new, innovative opportunities for residents and businesses."

"Los Angeles continues to be the nation's leader in tech jobs and tech sector growth," said Gary L. Toebben, President & CEO, Los Angeles Area Chamber of Commerce. "Building a modern, 21st century communications network, which includes advanced broadband is essential for Los Angeles to remain competitive in today's global marketplace. AT&T understands this and has invested billions into the Greater Los Angeles area over the last few years."

The AT&T LTE network covers 365 million people in North America. In 2015, we made these Los Angeles network enhancements:

- Expanded LTE network throughout Los Angeles and Orange Counties
- DAS installation at Los Angeles and Santa Ana airports
- DAS deployment in support of major college football bowl game in Pasadena

We also offer our award-winning DIRECTV® service to eligible locations. Customers may be eligible for AT&T U-verse TV service, a 100% digital service available over our advanced network. In 2015, Woman's Choice Awards® named AT&T U-verse "America's Most Recommended Brand among women for Broadband, Television and Phone Service."

AT&T GigaPower offers our fastest Internet speeds, up to 1Gbps⁴ over a 100% fiber network to more than 1.6 million locations across 22 major metro areas. We've announced plans to expand the availability of Internet speeds up to 1Gbps to homes, apartments and small businesses in parts of 34 additional cities across the U.S. – which will total at least 56 metros served.

We plan to continue to roll out our fastest Internet services over a 100% fiber network to reach more than 14 million additional residential and commercial locations.

We have big plans for 2016. We'll be giving you the ability to access and stream DIRECTV video services over a wired or wireless Internet connection from any provider and from virtually any device – smartphone, tablet, Smart TV, streaming media hardware or PC. We plan for each service to come with a set number of simultaneous sessions. These services will not require annual contracts, satellite dishes or set-top boxes.

We have an extensive Wi-Fi network with more than 40,000 AT&T Wi-Fi Hot Spots at popular restaurants, hotels, bookstores and retailers. And we provide access to Wi-Fi at more 1 million locations around the world. Most AT&T smartphone customers and home Internet customers get access to our entire national Wi-Fi network at no additional cost. Wi-Fi usage doesn't count towards customers' monthly wireless data plans⁵.
