



AT&T Invests More Than \$275 Million Over 3-Year Period to Enhance Local Networks in West Virginia

CHARLESTON, W.Va, May 19, 2016 — At [AT&T](#)¹, we invested **more than \$275 million** in our West Virginia wireless and wired networks during 2013-2015, and made 742 wireless network upgrades during that time. These investments drive a wide range of upgrades to reliability, coverage, speed and overall performance for residents and businesses. They also enhance critical services that support public safety and first responders.

In 2015, AT&T made multiple wireless network upgrades in West Virginia. We added two new 4G LTE sites in Huntington and Charleston, and upgraded ten existing sites in Charleston and Beckley.

Notable West Virginia network enhancements in 2015 included:

- **Upgrading four 4G LTE cell sites in Beckley, Greenbrier and Raleigh**
- **Upgrading six 4G LTE cell sites in Charleston**
- **Building a new 4G LTE cell site in Charleston**
- **Building a new 4G LTE cell site in Huntington**
- **Installing a Distributed Antenna System to boost service at Charleston Town Center**

“We’re committed to providing our customers fast, reliable, highly secure connectivity. We want them to be able to access the Internet at any moment, from almost any device and anywhere,” said J. Michael Schweder, president of AT&T Mid-Atlantic. “Our continued investment in West Virginia brings a host of new, innovative opportunities for residents and businesses.”

plan for each service to come with a set number of simultaneous sessions. These services will not require annual contracts, satellite dishes or set-top boxes.

We have an extensive Wi-Fi network with more than 40,000 AT&T Wi-Fi Hot Spots at popular restaurants, hotels, bookstores and retailers. We provide access to Wi-Fi at more than 1 million Hot Spots around the world. Most AT&T smartphone and home Internet customers get access to our entire national Wi-Fi network at no additional cost. Wi-Fi usage doesn't count towards customers' monthly wireless data plans.²
